Students may **not** return to their vehicle at any time during the school day without obtaining a pass from the office. Students who violate the parking rules or operate their cars in a less than safe manner risk having their parking privileges revoked, their vehicle towed at owner's expense, their vehicle booted, a fee, or other disciplinary action as taken by an administrator. Note: School Property is under 24 hour's video surveillance.
